55. Overcharging

- 55.1 If **you** have been overcharged by **us**, within 10 **business days** of being informed of the overcharge, **we** will ask **you** for instructions regarding whether any overcharged amount should be repaid to **you** or added to the balance of **your pre-payment meter** account.
- 55.2 **You** need to provide **us** with instructions for the overcharged amount within 20 **business days**. If, after 20 **business days**, **you** do not provide **us** with any instructions, **we** must add the overcharged amount to the balance of **your pre-payment meter** account.

56. Reconnection after self-disconnection

- 56.1 Further to Clause 28, if **you** are **self-disconnected** due to running out of **credit** (including, but not limited to running out of any **friendly credit** or **emergency credit**), **your pre-payment meter** will recommence supply as soon as information is communicated to the **pre-payment meter** that a payment to **your** account has been made which brings **your** balance into **credit**.

57. Privacy and confidentiality

- 57.1 In addition to the information stated in Clause 12, **we** also collect and retain the following information specifically for **pre-payment metering customers**:
- (a) the explicit informed consent provided when **you** enter into a **pre-payment meter** arrangement,
  - (b) information about **self-disconnections** due to running out of **emergency credit**, and
  - (c) information about offers made to **you** to revert the **pre-payment meter** to a standard **post-payment meter** operating mode.

## FISHERIES MANAGEMENT (PRAWN FISHERIES) REGULATIONS 2017

### *Variation on Prohibition of Fishing Activities in the Spencer Gulf Prawn Fishery*

Take note that pursuant to Regulation 10 of the *Fisheries Management (Prawn Fisheries) Regulations 2017*, the notice dated 19 September 2024 published on page 3811 of the *South Australian Government Gazette* on 26 September 2024 prohibiting fishing activities in the Spencer Gulf Prawn Fishery, is hereby varied such that it will not be unlawful for a person fishing pursuant to a Spencer Gulf Prawn Fishery licence to use prawn trawl nets in the areas specified in Schedule 1, during the period specified in Schedule 2, and under the conditions specified in Schedule 3.

#### SCHEDULE 1

The waters of the Spencer Gulf Prawn Fishery:

(a) Except the Northern closure area, which is defined as the area north of the following index points:

1. 33°12.50S 137°50.00E

# ***Energy Resources Act 2000***

## **GAS STORAGE EXPLORATION LICENCE GSEL 797**

I, BENJAMIN ZAMMIT, Executive Director, Regulation and Compliance Division, Department for Energy and Mining, in the State of South Australia, pursuant to the provisions of the *Energy Resources Act 2000*, Clause 4 the *Petroleum (Miscellaneous) Amendment Act 2009* and all other enabling powers, for and on behalf of the Minister for Energy and Mining (Minister), pursuant to delegated powers dated 19 August 2024, HEREBY ISSUE to:

**CCS Arckaringa Pty Ltd**  
ACN 673 369 063

(hereinafter referred to as the Licensee) an Exploration Licence in relation to a natural reservoir for the purpose of gas storage in respect of the area set out below, to have effect from 26 November 2024 and to expire on 31 December 2024 but carrying the right to renewal subject to the provisions of the *Energy Resources Act 2000*.

### **DESCRIPTION OF AREA**

The land comprised in this licence is that part of the State of South Australia described in the Schedule hereto.

### **CONDITIONS**

1. During the term of the licence, the Licensee shall carry out or cause to be carried out, exploratory operations on the area comprised in the licence in accordance with such work programs as are approved by the Minister from time to time. Year one exploratory operations are guaranteed, and any subsequent licence year work program becomes guaranteed upon entry into any such licence year. These exploratory operations shall include but not necessarily be limited to:-

2. All regulated activities authorised by the Licence are classified as requiring high level official surveillance, unless the Licensee satisfy the Minister, that in view of the Licensee's demonstrated competence to comply with the requirements of the Act and the conditions of this Licence, the activities should be classified as requiring low level official surveillance.
  - 2.1 The Minister's prior written approval is required for activities requiring high level official surveillance in accordance with Regulation 19 of the Regulations to the Act.
3. In the event that the Licensee during any year of the term of this licence fails to comply with the work program requirements of this licence, it is an express term of this licence that the Minister may, at his discretion, either cancel this licence or authorise such variation to these requirements as the Minister thinks fit.
4. The Licensee must:
  - (a) maintain in force during the term of this licence public liability insurance to cover regulated activities under this licence (including sudden and accidental pollution) in the name of the Licensee for a sum not less than twenty million dollars (\$20,000,000.00) or such greater sum as specified by the Minister, and make such amendments to the terms and conditions of the insurance as the Minister may from time to time require;
  - (b) maintain in force during the drilling of any well or operation in any well, control of well insurance in the name of the Licensee for a sum not less than ten million dollars (\$10,000,000.00) or such greater sum as specified by the Minister, and make such amendments to the terms and conditions of the insurance as the Minister may from time to time require; and
  - (c) upon request by the Minister, provide the Minister with a cover note or certificate of currency of each insurance policy referred to in paragraphs (a) and (b)
5. The Minister in specifying the levels of insurance accepts no liability for the completeness of their listing, the adequacy of the sum insured, the limit of liability, the scoped coverage, the conditions or exclusions of these insurances in respect to how they may or may not respond to any loss, damage or liability.
6. The Licensee will ensure, when preparing an Environmental Impact Report under Part 12 of the *Energy Resources Act 2000*, that the report also includes an assessment of the potential economic consequences for other Licensees under the *Energy Resources Act 2000* or *Mining Act 1971* and owners of land, arising out of proposed regulated activities to be carried out in the licence area.
7. A contract or agreement entered into by the Licensee to transfer or accept liability for any well or facility constructed for the purpose of undertaking a regulated activity under the *Petroleum Act 1940* or *Energy Resources Act 2000* cannot transfer, limit or exclude liability under the *Energy Resources Act 2000* unless written consent of the Minister is obtained.
8. The Licensee shall during periods determined by the Minister, lodge and maintain with the Minister, in the form acceptable to the Minister, for the satisfaction of obligations arising under the Act or this licence, a security as specified by the Minister from time to time ("the Security"). The Security shall be lodged in the form of either:
  - (a) cash; or
  - (b) an unconditional, irrevocable bank guarantee or letter of credit in a form, and from a financial institution, approved by the Minister.

- 8.1 Interest will not be payable by the Minister to the Licensee on any cash Security.
- 8.2 All charges incurred by the Licensee in obtaining and maintaining the Security shall be met by the Licensee.
- 8.3 If upon expiry, this Licence is not renewed and the Minister is satisfied that there are no further obligations under this Licence or the Act, the Minister will return the Security to the Licensee.

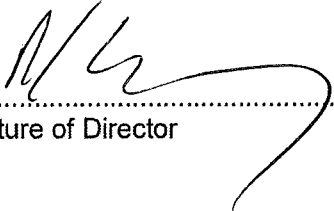

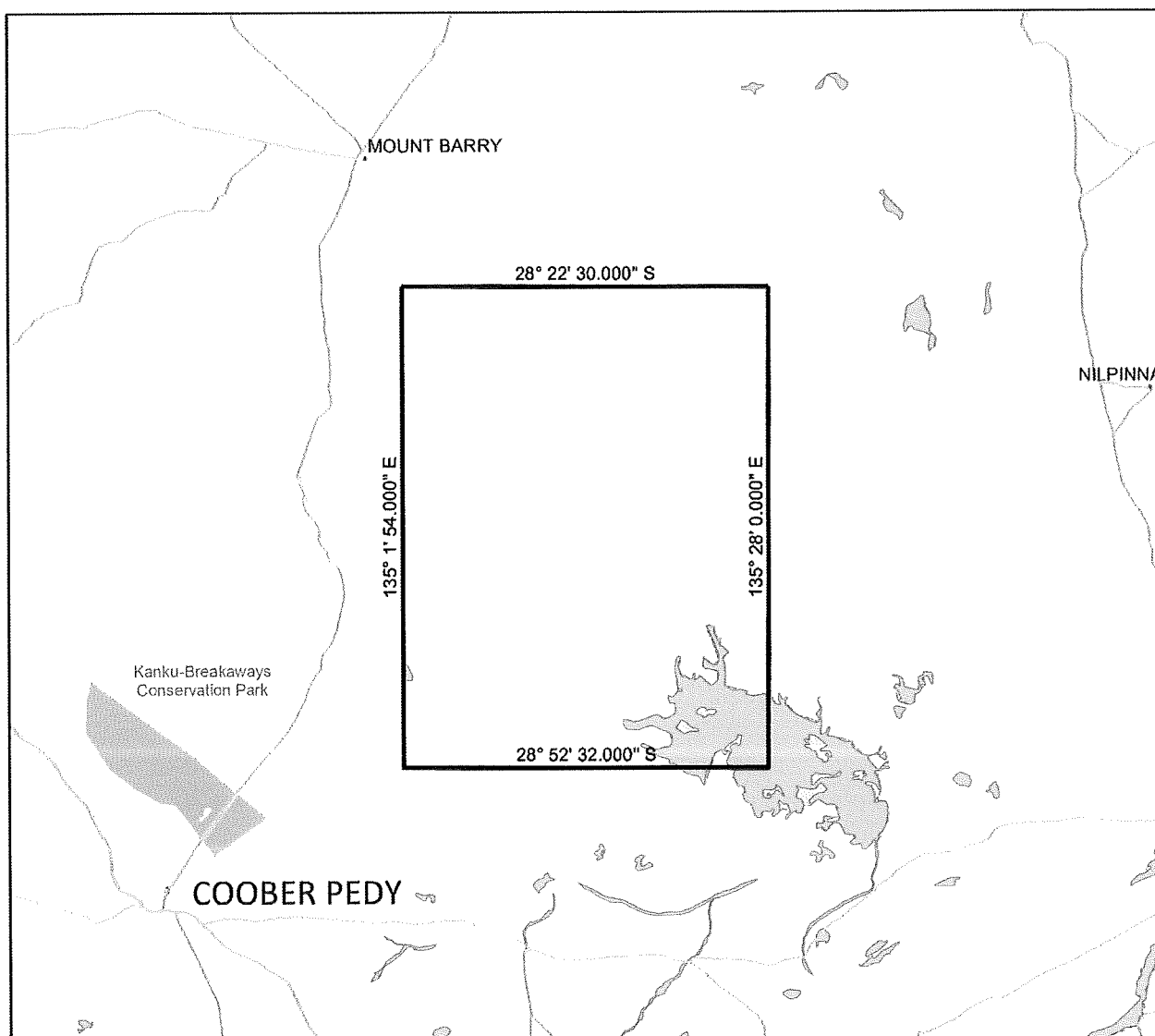
