- (a) Suspend the commitments under licence condition 12.2 of petroleum retention licences (PRLs) 221, 222, 223, 227, 229 and 230 for the period from 25 April 2026 to 24 April 2027 inclusive; and
- (b) Suspend the commitments under licence condition 12.2 of petroleum retention licences (PRLs) 224, 226 and 228 for the period from 16 March 2026 to 15 March 2027 inclusive; and
- (c) Suspend the commitments under licence condition 12.2 of petroleum retention licence (PRL) 225 for the period from 24 October 2025 to 23 October 2026 inclusive; and
- (d) Extend the term of PRLs 221, 222, 223, 227, 229 and 230 by the corresponding period of suspension, such that PRLs 221, 222, 223, 227, 229 and 230 will now expire on 24 April 2027; and
- (e) Extend the term of PRLs 224, 226 and 228 by the corresponding period of suspension, such that PRLs 224, 226 and 228 will now expire on 15 March 2027; and
- (f) Extend the term of PRLs 225 by the corresponding period of suspension, such that PRL 225 will now expire on 23 October 2026.

- (g) As a consequence of the suspension and extension of PRL 226, the term of the adjunct AALs 325 and 326 is extended, such that AALs 325 and 326 will now expire on 15 March 2027.

(hereinafter referred to as the Licensees) an Associated Activities Licence as an adjunct to Petroleum Retention Licence PRL 226 in respect of the area set out below, to have effect from 16 August 2025 and to expire on 15 March 2026 and carrying the right of renewal subject to the provisions of the *Energy Resources Act 2000*.

DESCRIPTION OF AREA

The land comprised in this licence is that part of the State of South Australia described in the Schedule hereto.

CONDITIONS

1. During the term of the licence, the Licensees may carry out or cause to be carried out the construction, operation and maintenance of an access road, flowline and associated infrastructure within the land described in the Schedule hereto.
2. Pursuant to Section 74 of the Act, the regulated activities to be carried out pursuant to this Licence are classified as requiring low level official surveillance.
3. The Licensees must:
 - (a) upon commencement of regulated activities under this licence, maintain in force during the term of this licence public liability insurance to cover regulated activities under this licence (including sudden and accidental pollution) in the name of the Licensees for a sum not less than twenty million dollars (\$20,000,000.00) or such greater sum as specified by the Minister, and make such amendments to the terms and conditions of the insurance as the Minister may from time to time require;
 - (b) upon request by the Minister, provide the Minister with a cover note or certificate of currency of the insurance policy referred to in paragraph (a).

4. The Minister in specifying the levels of insurance accepts no liability for the completeness of their listing, the adequacy of the sum insured, the limit of liability, the scoped coverage, or the conditions or exclusions of these insurances in respect to how they may or may not respond to any loss, damage or liability.

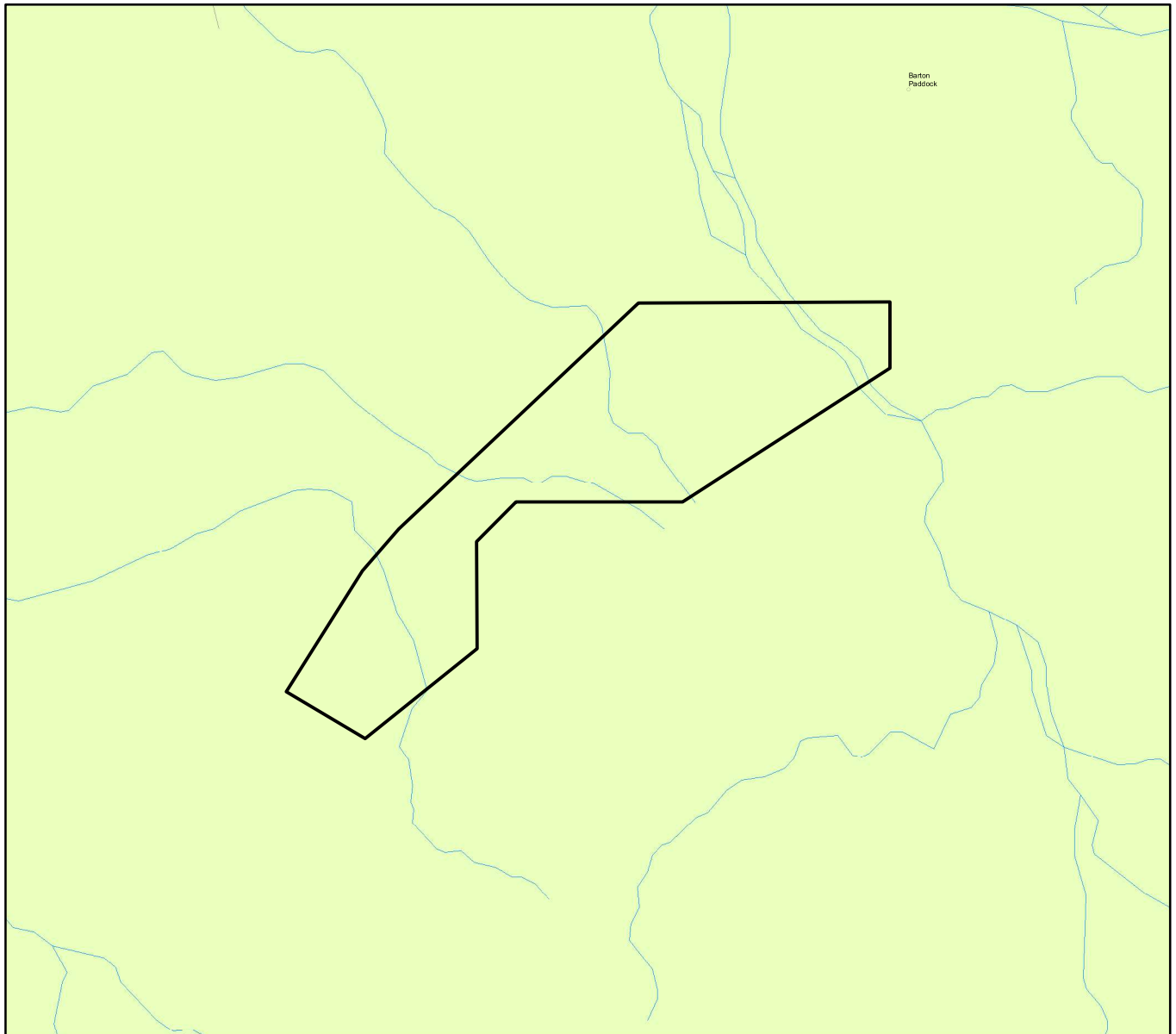
